PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DANGER. Corrosive. Causes irreversible eye damage and skin burns. Harmful if swallowed or absorbed through the skin. Do not get in eyes, on skin, or on clothing. Wear goggles or face shield and chemical-resistant gloves and protective clothing when handling. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Remove contaminated clothing and wash clothing before reuse.

ENVIRONMENTAL HAZARDS

This product is toxic to fish, aquatic invertebrates, oysters and shrimp.

This product is for use on hard, non-porous surfaces in Hospitals, medical and dental offices and clinics, healthcare facilities, nursing homes, kindergartens, restaurants and bars, kitchens, cafeterias, fast food operations, supermarkets, convenience stores, retail and wholesale establishments, institutional facilities, laboratories, businesses, office buildings, public restrooms, hotels, motels, workstations, schools, colleges, churches, athletic facilities, locker rooms, exercise facilities, and gymnasiums. This product is formulated for use on hard, non-porous surfaces such as: Counters, stovetops, sinks bathroom/kitchen, tanning spas/beds, tanning equipment, sealed floors, walls, ceilings, tables, hard non-porous surfaces of chairs, desks, washable walls, cabinets, doorknobs and garbage cans/pails, chrome and vinyl, painted surfaces, plastic, glazed ceramic, glazed porcelain, plated or stainless steel, aluminum, laminated surfaces and enameled surfaces. Non-dulling formula eliminates the time and labor normally required for rinsing floors. This product is an effective fungicide against *Trichophyton interdigitale* a fungus which may cause athlete's foot, a fungus which may cause Ringworm and *Candida albicans* on hard, non-porous surfaces in the presence of 5% blood serum and 400 ppm water hardness as CaCO3 when used on hard, non-porous surfaces in areas such as locker rooms, dressing rooms, shower and bath areas, exercise facilities. This product will effectively inhibit the growth of mold and mildew (*Aspergillus niger*) and the odors caused by them when applied to hard, non-porous surfaces leaving bathrooms and kitchens clean and fresh smelling.

DISINFECTION PERFORMANCE: This product kills the following bacteria in 10 minutes at 0.5 oz. per gal. of 400 ppm hard water and 5% soil on hard, non-porous surfaces: *Acinetobacter baumannii*, *Chlamydia psittaci*, *Enterobacter cloacae*, *Escherichia coli*, *Escherichia coli* O157:H7, *Enterococcus faecalis* (Vancomycin Resistant) (VRE), *Klebsiella pneumoniae*, *Klebsiella pneumoniae* (Carbapenem-Resistant), *Listeria monocytogenes*, *Micrococcus luteus*, *Proteus vulgaris*, *Pseudomonas aeruginosa*, *Pseudomonas aeruginosa* (Tetracycline Resistant), *Pseudomonas cepacia*, *Salmonella enterica*, *Shigella flexneri*, *Staphylococcus aureus*, *Staphylococcus aureus* (Community Associated Methicillin Resistant) (CA-MRSA), *Staphylococcus aureus* (Methicillin Resistant) (MRSA), *Staphylococcus epidermidis*, *Staphylococcus epidermidis* (Ampicillin, Cefazolin, Oxacillin, Penicillin Resistant), *Streptococcus pneumoniae* (Penicillin Resistant), *Streptococcus pyogenes*, *Staphylococcus aureus* (Vancomycin Intermediate Resistant) (VISA), *Yersinia enterocolitica*.

IRUCIDAL* PERFORMANCE: This product kills the following viruses in 10 minutes at 0.5 oz. per gal. of 400 ppm hard water and 5% soil on hard, non-porous surfaces: Avian Influenza A (H3N2) Virus, Avian Influenza A (H5N1) Virus, Cytomegalovirus, Coronavirus (SARS-associated), Hepatitis B Virus, Hepatitis C Virus, Herpes Simplex Virus Type 1, Herpes Simplex Virus Type 2, Human Coronavirus, Human Immunodeficiency Virus Type 1*** (HIV 1), Influenza A Virus (H3N2), Influenza A Virus (H1N1), Respiratory Syncytial Virus, SARS-CoV-2*** (COVID-19 Virus).

*** Indicates a 2-minute contact time is required for this claim.

NON-FOOD CONTACT SANITIZING PERFORMANCE: This product is an effective one-step sanitizer in 3 minutes at 0.5 oz. per gal. of 400 ppm hard water and 5% soil on hard, non-porous surfaces against: *Klebsiella pneumoniae*, *Staphylococcus aureus*.

FUNGICIDAL PERFORMANCE: This product kills the following fungi in 10 minutes at 0.5 oz. per gal. of 400 ppm hard water and 5% soil on hard, non-porous surfaces: *Candida albicans*, *Trichophyton nderdigitale* (Athlete's foot fungus) (Ringworm fungus).

MILDEWSTATIC PERFORMANCE: This product controls the following mold for up to 7 days at 0.5 oz. per gal. of 400 ppm hard water and 5% soil on hard, non-porous surfaces: *Aspergillus niger*.

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Rinse hard, non-porous food contact surfaces with potable water after application of product. Allow surfaces to come to room temperature before treatment. Before using this product, food products and packaging materials must be removed from the room or carefully protected.

This product is not for use on medical device surfaces.

FOR USE AS A GENERAL, HOSPITAL, MEDICAL DISINFECTANT, FUNGICIDE, VIRUCIDE*, CLEANER: 1. Pre-clean visibly soiled areas. 2. Prepare a use solution of 0.5 oz. of this product per gal. of water (or equivalent use dilution). To disinfect hard, non-porous, non-food contact surfaces, apply use solution with a sponge, brush, cloth, mop, by immersion, auto scrubber, mechanical spray device, hand pump trigger spray device, coarse trigger spray device. For spray applications, spray 6-8 inches from surface. Do not breathe spray. 3. Treated surfaces must remain visibly wet for 2 minutes to kill SARS-CoV-2 or for 10 minutes to kill all organisms listed on the label. 4. Allow to air dry. Rinsing of floors is not necessary unless they are to be waxed or polished. 5. Prepare a fresh solution daily or when visibly dirty.

Personal Protection: Wear protective latex gloves, gowns, masks, and eye protection. **Cleaning Procedure:** Blood and other body fluids containing HIV-1, HBV & HCV must be thoroughly cleaned from hard, non-porous surfaces and objects before application of this product. **Disposal of Infectious Materials:** Blood and other body fluids, cleaning materials and clothing must be autoclaved and disposed of according to federal, state, and local regulations for infectious waste disposal. **Contact Time:** Allow hard, non-porous surfaces to remain visibly wet for 2 minutes to kill HIV and 10 minutes for all organisms listed on the label.

NON-FOOD CONTACT SURFACE SANITIZING DIRECTIONS

NON-FOOD CONTACT SURFACE SANITIZING: Pre-clean visibly soiled areas. Add 0.5 oz. of this product per gal. of water (660 ppm active). Apply solution to hard, non-porous surfaces with a sponge, brush, cloth, mop, by immersion, auto scrubber, mechanical spray device, hand pump trigger spray device, coarse trigger spray device. For spray applications, spray 6 - 8 inches from surface. Do not breathe spray. Treated surfaces must remain visibly wet for 3 minutes. Prepare a fresh solution daily or when visibly dirty.

TO CONTROL MOLD/MILDEW: Pre-clean visibly soiled areas. Prepare use solution by adding 0.5 oz. of this product per gal. of water. Apply use solution to hard, non-porous surfaces which will effectively inhibit the growth of mold and mildew and their odors. Repeat treatment every 7 days, or more often if new growth appears.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

PESTICIDE STORAGE: Store only in original container. Keep this product under locked storage sufficient to make it inaccessible to children or persons unfamiliar with its proper use.

PESTICIDE DISPOSAL: Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture or rinsate is a violation of federal law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste Representative at the nearest EPA Regional Office for guidance.

CONTAINER HANDLING: Non-Refillable Container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Fill the container 1/4 full with water and recap. Shake for 10 seconds. Drain for 10 seconds after the flow begins to drip. Follow Pesticide Disposal instructions for rinsate disposal. Repeat this procedure two more times. Then offer for recycling if available or puncture and dispose of in a sanitary landfill, or by incineration.
